- 1. When the owner decides to lease his/her apartment (within the applicable restrictions), he/she completes the "Request for Approval of Lease" form, signs it, has the prospective lessee sign it and delivers it immediately to the President.
- The President may arrange for the prospective lessee to meet with the Board of Directors, checks references and calls a meeting of the Board of Directors who review the request.
- 3. Within thirty (30) days after receipt of the request, the Board of Directors approves and sends a "Certificate of Approval lessee", or disapproves and returns the request, so marked, to the owner.

NOTE: In the absence of the President, the Vice President, Secretary or Treasurer, in that order, acts for the Board of Directors.
